

inadequacy in the area.

A decision on the development has been postponed until the City Commissioners regular meeting on July 7th, at which time the commissioners will hear the recommendation of the variance board before making a decision on the Interested citizens should attend the July 7th meeting at 7:30 p.m. in the courtroom at City Hall.



## Resolution

The WPNA has adopted a resolution supporting the City Commission in its opposition to the construction of the Howard Street Connector, also known as the Decatur Parkway, and the widening of Scott Boulevard within the city limits of Decatur.

The following reasons were given for the support of the city's

decision:

- 1. The construction or enlargement of either of the vehicular traffic routes is unwarranted by present or projected traffic flows along these corridors.
- 2. It would discourage energy conservation by encouraging the use of cars rather than public transportation, which is available in the the same corridor.
- 3. The construction of the Howard Street Connector will produce increased vehicular traffic on all of Decatur neighborhood streets and will, by acquisition, destroy the neighborhood of Sycamore Street.
- 4. The enlargement of Scott Boulevard is the inevitable result of the proposal by the Department of Transportation to facilitate through traffic along that corridor, and that enlargement will have a significant negative impact on the Decatur tax base.

## COMMISSION NOTES

The June 2nd Decatur City Commission meeting began with intern reports of Decatur High students under the direction of Dr. Soff. Laura Murphey and Nancy Henning had studied Oakhurst Park and offered some innovative ideas for its improvement. Elaine Fielding and Amy Plankenhorn, who had studied crime statistics, reported their findings. The commission awarded a bid for the construction of the East Lake Drive storm drainage system. They authorized the use of \$218,000 from the Small Cities budget for the project, the cost of which is not to exceed \$193,872. Because many homeowners are now doing much of their own construction work, the Commission approved a building code of minimum standards for one and two family dwellings
rewritten in layman's language.
At the June 16th City Commission
meeting, Robert Gibbs, Director of the

Decatur Recreation Center, was awarded a pin for 15 years of service. Decision on the planned unit development application of Wales Thomas was delayed because the Variance Board had not voted on it. Property at 413 Melrose was sold by the City to the highest bidder. The appointment of a new Sanitation Director was confirmed. The Commission waived the penalty for late payment of taxes on the property on which the Decatur Post Office now sits. The property is owned by a N. C. development company. The penalty could amount to \$700 to \$900. Residents living near the First Christian Science Church on Clairmont were concerned about the purchase by the church of a lot facing Ponce de Leon Place. The church plans to remove the house and pave the entire area for parking, possibly creating drainage problems.
